WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the APWA TREASURE COAST BRANCH EQUIPMENT ROADEO on October 21, 2026 I hereby release, waive, discharge and covenant not to sue APWA, the Treasure Coast Branch, the City of Port St. Lucie, the MidFlorida Event Center, its officers, servants, agents and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the APWA TREASURE COAST BRANCH EQUIPMENT ROADEO, or while in, on or upon the premises where the ROADEO is being conducted, while in transit to or from the premises, or in any place or places connected with the ROADEO.

2. I am fully aware of risks and hazards connected with being on the premises and participating in the ROADEO, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the ROADEO, and I hereby elect to voluntarily participate in the ROADEO, to enter upon the above-named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the ROADEO, whether caused by the negligence of releasees or otherwise.

3. I further hereby agree to indemnify and save and hold harmless APWA, the Treasure Coast Branch, and the City of Port St. Lucie from any loss, liability, damage or costs they may incur due to my participation in the ROADEO, whether caused by the negligence of any or all of the releasees, or otherwise.

4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named releasees.

5. It is agreed that this is a voluntary event and that I will receive no compensation for my time or expenses.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
- C. I am at least eighteen (18) years of age and fully competent; and
- D. I execute this Release for full, adequate, and complete consideration fully intending to be bound by same.
